Review papers. The journal also publishes topical reviews in emerging areas of biological science that will be of interest to non-specialists. Topical reviews are commissioned but unsolicited submissions will be considered.

Comment papers. Short additions to, or criticisms of, papers already published in this journal will also be considered. At the discretion of the editors, the authors of the original paper may be invited to reply. Comment papers should be short, interesting and conform to the rules of good manners.
